# ADMISSION TO THE MASTER OF SOCIAL WORK IN CHILD PROTECTION FOR 2022

# 1. Admission criteria

### 1.1 From the yearbook:

### **Programme: Child Protection**

#### **Qualification code: 8EU P01**

Completion of this qualification will allow students admission to doctoral studies in social work.

Closing date for applications is 30 September.

#### Faculty specific rules and requirements of the programme

- a) A four-year Bachelor's degree in Social Work is required.
- b) Candidates must have achieved an average of 60% in the Bachelor's degree in Social Work.
- c) Completion of an academic literacy test will be required.
- d) Each applicant will be subjected to a selection interview conducted by a postgraduate panel of the subject group. For this purpose, a structured interview schedule will be used, and the average of panellist's ratings will serve as selection criterion.
- e) Each candidate must submit a mini-research proposal as part of the selection process;
- f) A Satisfactory academic progress should be maintained. The department is free to terminate a student's study if the academic progress is unsatisfactory.

### 1.2 General admission requirements

- a) A four-year Bachelor's degree in Social Work.
- b) Students enrolling for this programme must provide proof of registration as Social Worker as required by the Act on Social Service Professions 1978 (Act 110 of 1978).
