General information:

- The Health Research Ethics Office has an administrative fee structure for external reviews in place, which is revised annually.

- The RECs reserve the right not to review a research application, or to withhold an HREC/AnimCare letter, if administrative fees are outstanding.
- The RECs reserve the right not to review an application if it feels that it falls outside the expertise of the REC.

Payment Process:

Non-affiliated researchers

- Submit a completed Invoice Application Form (SFD005e) (available on the website: <u>http://health-sciences.nwu.ac.za/healthethics</u>) with your application documentation to <u>Ethics-HRECApply@nwu.ac.za</u> for human research or <u>Ethics-AnimCare@nwu.ac.za</u> for animal research.
- 2) Your *invoice application* will be processed by Ms Carolien van Zyl (Ethics Office Financial Officer). An Official NWU Invoice will be requested, generated and send to you via e-mail. All relevant information for payment will be indicated on the invoice for your convenience. *Please use the invoice number as reference*.
